

SEAPORTS PROGRAM – 2009/10 SEAPORTS PROGRAM FEE SCHEDULE ADVICE TO SHIPPING INDUSTRY – SEAPORTS - 02 / 09

The Australian Quarantine and Inspection Service's (AQIS's) fees and charges have been reviewed with a new fee schedule being implemented on 1 July 2009 that will be utilised throughout the 2009/10 financial year.

Section 86E of the *Quarantine Act 1908* provides that the Minister may determine fees in respect of specified services provided under the Act.

The review of the Seaports Program fees was undertaken in consultation with the AICCC. The revised fee schedule better aligns the charges to the cost of delivering program services. The revised Seaports Programs Fee Schedule is provided at Attachment A.

From Wednesday 1 July 2009, the revised Quarantine Service Fees Determinations 2005 will be available on the AQIS internet at www.aqis.gov.au/fees. The Seaports Program Fees and Charging Guidelines will also be available from 1 July 2009 at www.aqis.gov.au/charging
