### OIL AND GAS SERVICES TARIFFS 2014

The Ghana Ports and Harbours Authority (GPHA) hereby announces the introduction of Special Tariffs - OIL AND GAS SERVICES TARIFFS - to be applicable to Operators in the Offshore Oil and Gas Sector who use the facilities and services of the Ports. The OIL AND GAS SERVICES TARIFFS are addendum to the existing Ghana Ports Tariffs and are presented as Schedule Nine (9), thereof. The tariffs shall come into effect on February 1, 2014.

As part of the arrangements for the implementation of the Oil and Gas Service Tariffs, all Operators in the Oil and Gas Industry using the facilities and services of the Ports are required to complete a GPHA VENDOR APPROVAL which will form an addendum to the Port Business Operating Licence.
