**COVID-19 – Further Extension of Certificates of Seafarers**

Operational measures concerning impact of novel Corona Virus (COVID-19), adopted by the Republic of Turkey was conveyed with our letters which were circulated with Circular Letters 4245, 4245/Add.1, 4245/Add.4, 4245/Add.5 and 4245/Add.10.

Temporary measures that were taken according to the above-mentioned letters are valid until 30.06.2021.

Given the ongoing severity of the COVID-19 epidemic and unresolved challenges such as timely repatriation of seafarers at the end of their contract and revalidation of their expiring certificates, the vital need to extend the certificate periods of seafarers has arisen.

In this context, the validity of the Turkish Seafarers' Seaman's Books, Certificate of Competencies (COC), GMDSS Radio Operator Certificates (ROC/GOC/REO), STCW Certificates and Medical Fitness Certificates are granted general extension of validity up to **01.09.2021** without any further application or approval processes.
